

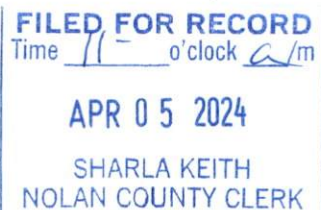
- 1. Open Public Hearing regarding a reinvestment zone for Solvent Energy.**


4. CONSIDER APPROVAL FOR BOND FOR NOLAN COUNTY TAX ASSESSOR/COLLECTOR.


5. ADJOURN.




