WHEREAS, that certain Deed of Trust (the "Deed of Trust"), dated December 15, 2014, from Charles R. Tames and Angela Flores ("Borrower"), as Grantor to Ryan Coggin, Trustee, filed for record as Instrument Number 15-17123 in Volume Number 1313, Pages 18-22 in Real Property Records of Nolan County, Texas, more particularly described therein, which serves as security for a \$44,500.00 promissory note described therein (the "Note") executed by Borrower payable to the order of HB Equity, LLC and subsequently assigned to Homestead Opportunity Fund, LP, on January 21, 2015 by Assignment of Mortgage/Deed, filed for record as Instrument Number 15-17235 on January 26, 2015 in Nolan County Texas Real Property records.

WHEREAS, the undersigned has been appointed Substitute Trustee in the place of the said original Trustee, upon the contingency and in the manner authorized by the Deed of Trust; and

WHEREAS, default, as same is defined in the Promissory Note and/or the Deed of Trust, has occurred and the outstanding indebtedness on same is now wholly due; and

WHEREAS, Homestead Opportunity Fund, LP, a Texas limited partnership, the Owner and Holder of the Promissory Note has requested the undersigned to sell the real property described in the Deed of Trust to satisfy said indebtedness.
