

NOTICE OF TRUSTEE'S SALE

WHEREAS, by Deed of Trust (hereinafter referred to as the "Deed of Trust") dated November 1, 2017, ERICA CABALLERO conveyed to Thomas L. Rees, Jr., Trustee for the benefit of JHRM RESOURCES, LLC, certain real property situated in Nolan County, Texas, more particularly described as follows, to wit:

(hereinafter referred to as the "Property") to secure the payment of one certain Real Estate Lien Note (hereinafter referred to as the "Real Estate Lien Note") dated November 1, 2017 and payable to the order of JHRM RESOURCES, LLC, which said Deed of Trust is recorded in Volume 1451, Page 29 of the Official Public Records of Nolan County, Texas, reference to which said Real Estate Lien Note and Deed of Trust and the recordation thereof is hereby made for all purposes; and,

WHEREAS, Notice of Default was forwarded to Debtors/Makers on April 22, 2021, by Certified Mail to require that delinquent installment payments and delinquent ad valorem taxes be cured within the time allowed therefor; and,

WHEREAS, the Real Estate Lien Note remained in default as of June 23, 2021, due to failure to cure the existing default under the Note; the owner and holder of the Real Estate Lien Note requested that Thomas L. Rees, Jr., Trustee, notify ERICA CABALLERO that the balance of the Note, including the outstanding principle and accrued interest balance of the Note is accelerated and is now fully due and payable and that the Property will be sold at foreclosure sale if ERICA CABALLERO fails to pay off the accelerated matured indebtedness prior to the date of the Trustee Sale; said Notice to Borrower was duly sent by certified mail on June 18, 2021 and resent on June 24,2021 via Certified Mail and Regular Mail;

WHEREAS, such default has not been cured as of the date of the posting of this Notice of Substitute Trustee's Sale, and the indebtedness evidenced therein is now wholly due and payable; and,

WHEREAS, JHRM RESOURCES, LLC, the beneficiary named in said Deed of Trust and the owner and holder of said lien and the Indebtedness secured thereby, has requested the undersigned to sell the Property at Public Auction to satisfy the Indebtedness.

NOW THEREFORE, NOTICE IS HEREBY GIVEN that on Tuesday, the 2nd day of August, 2021, between the hours of 10:00 a.m. and 4:00 p.m., I will sell the Property, at public auction for cash to the highest bidder, in the lobby area on the first floor of the Nolan County Courthouse. The lobby area on the first floor of the Nolan County Courthouse is the area which has been designated by the Nolan County Commissioner's Court for foreclosure sales. Said sale will begin at the earliest at 10:00 a.m. and will take place no later than three (3) hours after that time.
