1. I HAVE REQUESTED THE DRIVING SAFETY COURSE ON OR BEFORE MY ANSWER DATE EITHER IN PERSON OR BY MAIL.
2. I HOLD A VALID **TEXAS** OPERATOR'S DRIVER'S LICENSE OR PERMIT, **OR** I AM A MEMBER, SPOUSE OR DEPENDENT CHILD OF A MEMBER OF THE U.S. MILITARY FORCES SERVING ON ACTIVE DUTY WHO HOLDS AN OUT OF STATE DRIVER'S LICENSE.
3. I DO NOT HOLD A COMMERCIAL DRIVER'S LICENSE (CDL).
4. I HAVE PROOF OF FINANCIAL RESPONSIBILITY (LIABILITY INSURANCE), AND HAVE ENCLOSED A COPY.
