
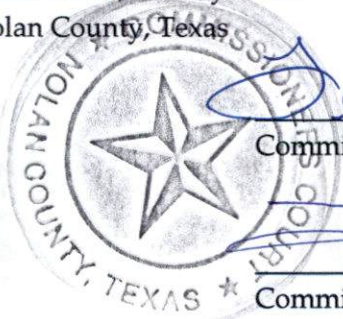
11. ADJOURN.


