

# Sheriff & Constable Fees

LOCAL GOVERNMENT CODE Sec. 118.131(e)

- (a) The commissioners court of a county may set reasonable fees to be charged for services by the offices of the sheriff and constables.
- (b) A notice setting out the fees shall be posted in the same manner in which notices are posted under Section 81.007 and shall be posted in the offices of the county officials who are authorized to charge the fees.
