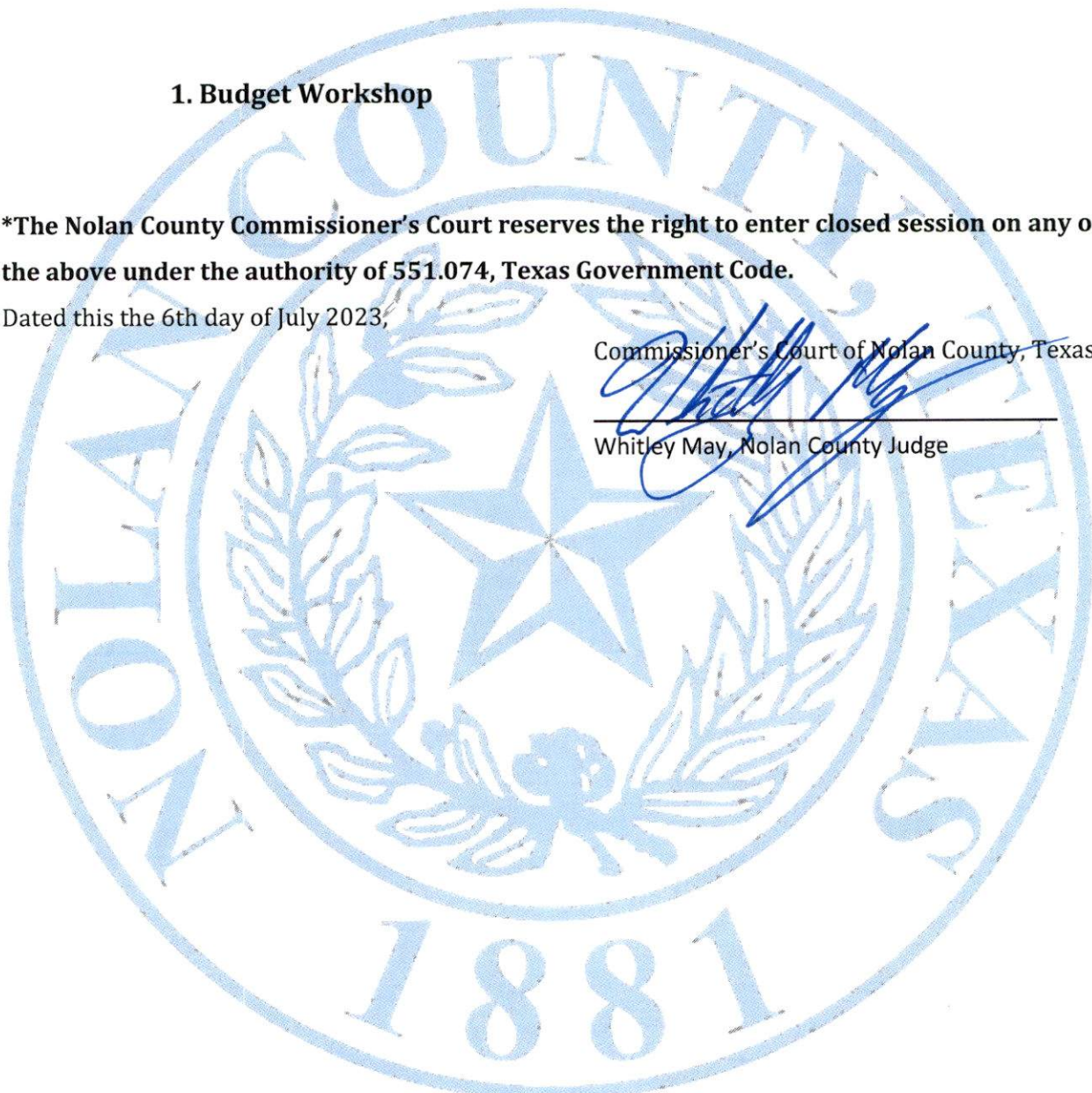

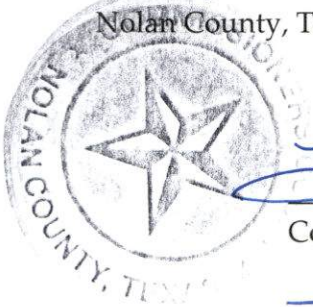
2. **ADJOURNED AT 2:30 P.M ON JULY 12TH, 2023**


