1. CONSIDER APPROVAL OF GUIDELINES FOR THE AUDITING OF FUNDS.

Motion was made by Commissioner Willman, seconded by Commissioner Ortega to pay the Coliseum Workers and Assistant Manager overtime on a biweekly period over 80 hours. Vote was taken and the members of the Court unanimously voted yes. Motion carried.

2. BUDGET WORKSHOP


