
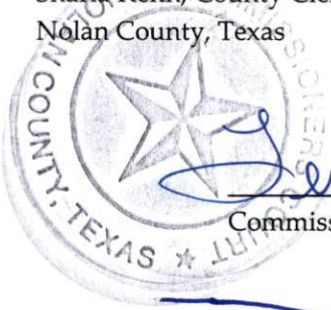
2. ADJOURNED AT 4:00 P.M ON JULY 17TH, 2024






