3. APPROVE MINUTES FROM MARCH 10TH, 2025, MEETING. (attachment)

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to approve the minutes from March 10th, 2025 as presented. Vote was taken and members of the court unanimously voted yes. Motion carried.

4. CONSIDER APPROVAL TO REINSTATE THE BURN BAN.

Motion was made by Commissioner Mahaffey, seconded by Commissioner Ortega to approve reinstating the Nolan County Burn Ban. Vote was taken and members of the court unanimously voted yes. Motion carried.

5. CONSIDER APPROVAL OF A PROCLAMATION MAKING APRIL CHILD ABUSE AWARENESS MONTH. (attachment)

Motion was made by Commissioner Willman, seconded by Commissioner White to approve a Proclamation making April *Child Abuse Awareness Month*. Vote was taken and members of the court unanimously voted yes. Motion carried.

6. RECEIVE 2024 AUDIT OF 32ND JUDICIAL DISTRICT COMMUNITY SUPERVISION AND CORRECTIONS DEPARTMENT. (attachment)

Motion was made by Commissioner White, seconded by Commissioner Willman to receive the 2024 audit of the 32nd Judicial District Community Supervision and Corrections Department. Vote was taken and members of the court unanimously voted yes. Motion carried.

7. CONDUCT A PUBLIC HEARING ON THE PROPOSED NOLAN COUNTY PACE PROGRAM.

There were no public comments made. The public hearing was closed and Commissioners' Court resumed.

8. CONSIDER AND TAKE POSSIBLE ACTION ON A RESOLUTION TO ESTABLISH THE NOLAN COUNTY PACE PROGRAM.

Motion was made by Commissioner Mahaffey, seconded by Commissioner Willman to approve a Resolution establishing the Nolan County PACE Program. Vote was taken and members of the court unanimously voted yes. Motion carried.

9. CONSIDER AND TAKE POSSIBLE ACTION TO APPROVE A PROFESSIONAL SERVICES AGREEMENT WITH TEXAS PACE AUTHORITY TO ADMINISTER THE NOLAN COUNTY PACE PROGRAM.

Motion was made by Commissioner Willman, seconded by Commissioner White to approve a professional services agreement with Texas PACE Authority to administer the Nolan County PACE Program. Vote was taken and members of the court unanimously voted yes. Motion carried.

10. CONSIDER APPROVAL OF A CONTRACT WITH CLOUDGAVEL USING JP TECHNOLOGY FUNDS. *(attachment)*

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to approve a contract with CloudGavel using the JP Technology Funds. Vote was taken and members of the court unanimously voted yes. Motion carried.

11. CONSIDER APPROVAL OF APPOINTMENTS TO AUDITORIUM BOARD. *(attachment)*

Motion was made by Commissioner White, seconded by Commissioner Mahaffey to approve the appointments of John Kergis and Alicia Brown, the reappointment of Jan Smith, and the reappointment of Bud E. Alldredge, Jr. DVM as the joint city/county appointee to the Auditorium Board. Vote was taken and members of the court unanimously voted yes. Motion carried.

13. CONSIDER APPROVAL OF TAX ABATEMENT GUIDELINES AND CRITERIA. *(attachment)*

Motion was made by Commissioner Willman, seconded by Commissioner White to approve the revised Tax Abatement Guidelines and Criteria. Vote was taken and members of the court unanimously voted yes. Motion carried.

Motion was made by Commissioner White, seconded by Commissioner Willman to approve the county purchasing the metal and Melvin Coe repairing the Health Department roof, and Trace Fomby repairing the storage building at the Sheriff's Department. Motion was made by Commissioner Willman, seconded by Judge May to go out for bids on any repairs needed from the wind damage to the coliseum. Vote was taken and members of the court unanimously voted yes. Motion carried.

17. RECEIVE REPORTS FROM DEPARTMENT HEADS. *(attachments)*

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to receive reports from the Nolan County. Vote was taken and members of the court unanimously voted yes. Motion carried.

18. PAY CLAIMS, LINE-ITEM TRANSFERS, AND BUDGET AMENDMENTS AS REQUESTED BY THE COUNTY AUDITOR. (attachment)

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to pay bills totaling \$272,771.19. Vote was taken and members of the court unanimously voted yes. Motion carried.


19. ADJOURN.


