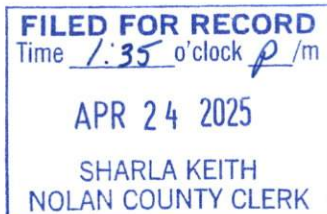

3. APPROVE MINUTES FROM APRIL 14TH, 2025, MEETING. *(attachment)*

Motion was made by Commissioner Mahaffey, seconded by Commissioner Willman to approve the minutes from April 14th, 2025 as presented. Vote was taken and members of the court unanimously voted yes. Motion carried.

4. OPEN, RECEIVE AND OR AWARD BIDS FOR COPIERS. *(attachments)*

Bids were opened and received from Ricoh, Toshiba, All Copy (Canon), and Xerox.

Motion was made by Commissioner Mahaffey, seconded by Commissioner White to go in to closed session and review all bids. Vote was taken and members of the court unanimously voted yes. Motion carried.
