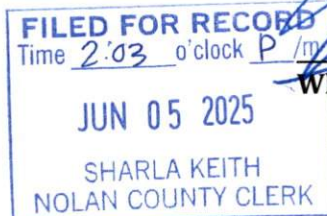

8. 1:30 HAZARD MITIGATION MEETING *(attachments)*

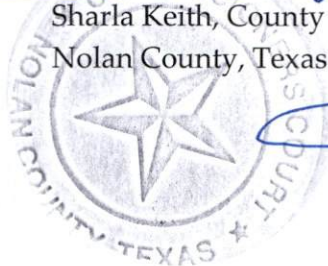
9. **ADJOURN.**


