
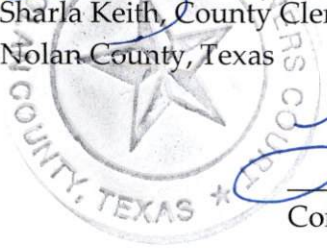
7. ADJOURN.


