

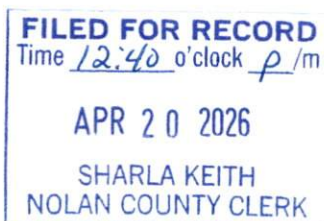

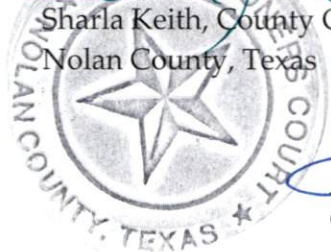
9. Adjourn.


Motion was made by Judge May, seconded by Commissioner Mahaffey to adjourn. Vote was taken and members of the court unanimously voted yes. Motion carried.
