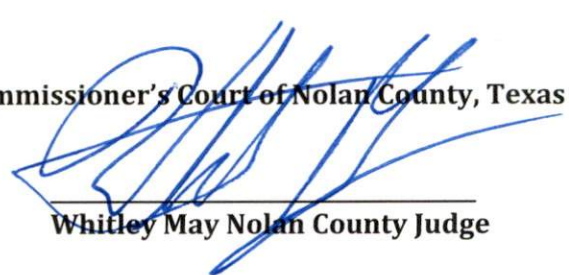
1. Pledge allegiance to the United States flag.

11. Pay claims, line-item transfers, and budget amendments, as requested by the County Auditor. (attachments)

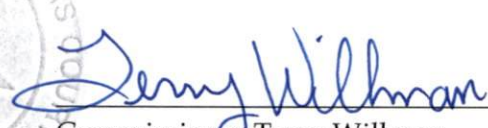
