

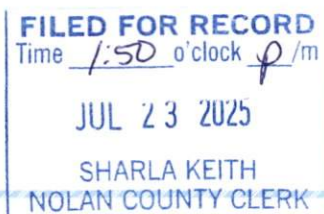


10. ADJOURN.


