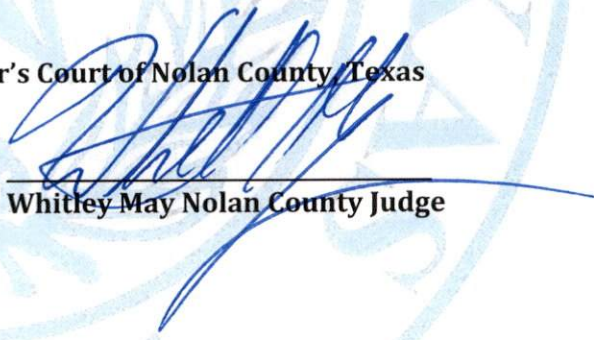

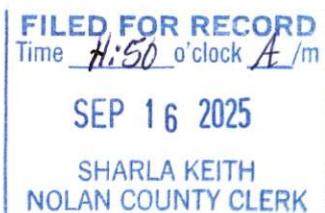
- 1. Pledge allegiance to the United States flag.**

3. APPROVE MINUTES FROM SEPTEMBER 8TH & 15TH, 2025 MEETING. *(attachment)*

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to approve the minutes from August 8th and 15th, 2025, as presented. Vote was taken and members of the court unanimously voted yes. Motion carried.

4. CONSIDER APPROVAL OF BOARD APPOINTMENTS TO THE COUNTY-CITY LIBRARY BOARD. *(attachment)*

Motion was made by Commissioner Willman, seconded by Commissioner Ortega to approve the appointment of Mary Bankhead and Frances Pilsner to the County-City Library Board. Vote was taken and members of the court unanimously voted yes. Motion carried.

5. CONSIDER APPROVAL TO PURCHASE OFFICE SUPPLIES. *(attachment)*

Motion was made by Commissioner Willman, seconded by Commissioner White to approve the purchase of a Replacement UPS for the County Clerk's Office, a Laser Printer and Trolley for the District Judge's Office, a File Cabinet for the Collections Office, a Screen Extender for the County Judges Office, and to hold off on the purchase of Toughbooks for the Sheriff's Office. Vote was taken and members of the court unanimously voted yes. Motion carried.

6. RECEIVE REPORTS FROM DEPARTMENT HEADS. *(attachments)*

Motion was made by Commissioner Mahaffey, seconded by Commissioner Ortega to receive reports from the Auditor, and the Nolan County Treasurer Quarterly Investment Report and Minutes. Vote was taken and members of the court unanimously voted yes. Motion carried.

7. PAY CLAIMS, LINE-ITEM TRANSFERS, AND BUDGET AMENDMENTS AS REQUESTED BY THE COUNTY AUDITOR. *(attachment)*

Motion was made by Commissioner Mahaffey, seconded by Commissioner Willman to pay bills totaling \$837,148.06. Vote was taken and members of the court unanimously voted yes. Motion carried.

8. DISCUSS AND MAKE ANY APPROPRIATE MOTIONS REGARDING PERSONNEL MATTERS.

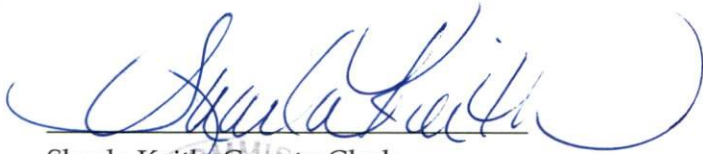
Motion was made by Judge May, seconded by Commissioner Willman to enter Closed Session. Vote was taken and members of the court unanimously voted yes. Motion carried.

No decisions were made while in Closed Session. Commissioners reconvened in Regular Session.

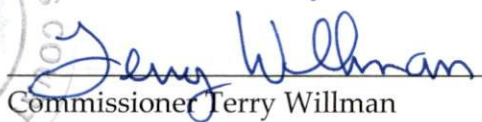
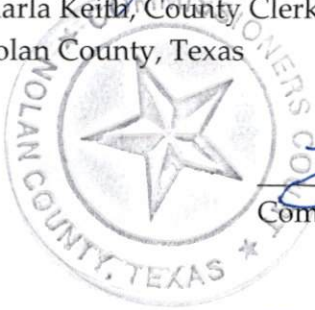
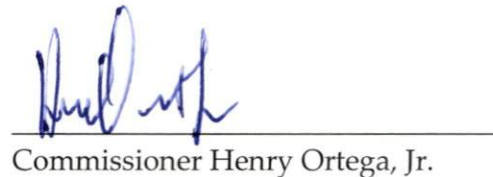
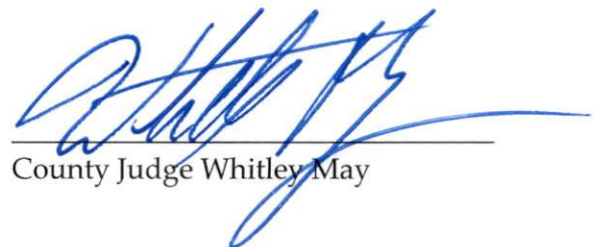
9. ADJOURN.
