The abatement agreement is proposed within the Harley Hand Solar & Storage Project Reinvestment Zone designated by the Commissioners Court of Nolan County, Texas on January 22, 2024 located in northeastern Nolan County. A map of the existent reinvestment zone is available for inspection in the office of the County Judge.

C. The proposed improvements are related to the construction of solar energy and storage facility including solar panels, tracking systems, battery energy storage systems (as such term is used in common language), inverters, transformers, foundations, containers, cabling, collection lines, collections stations, transmission lines, substations, interconnection facilities, operation and maintenance facilities, and other infrastructure, materials, and equipment customary and necessary for the operation of a solar power electric generation and battery energy storage facility.

D. The estimated cost of the improvements shall be in excess of \$300,000,000.00 with respect to the solar project and \$70,000,000.00 with respect to the storage project.



CONSIDER AND POSSIBLE ACTION ON AMENDING THE HARLEY HAND SOLAR AND STORAGE PROJECT TAX ABATEMENT AGREEMENT PURSUANT TO CHAPTER 312 OF THE TEXAS TAX CODE BETWEEN NOLAN COUNTY (THE 'COUNTY') AND HECATE HARLEY HAND SOLAR, LLC AND HEATE HARLEY HAND STORAGE, LLC (COLLECTIVELY THE 'HECATE'). IN COMPLIANCE WITH SECTION 312.207(c) OF THE TEXAS TAX CODE IN PERTINENT PART, THE PROPOSED TAX ABATEMENT AGREEMENTS.

- A. HECATE HARLEY HAND SOLAR, LLC AND HECATE HARLEY HAND STORAGE, LLC, OWNERS OF INTERESTS IN LANDS ELIGIBLE FOR ABATEMENT AGREEMENTS WITHIN THE REINVESTMENT ZONE SUBMITTED APPLICATIONS FOR TAX ABATEMENT AGREEMENTS.
- B. THE ABATEMENT AGREEMENT IS PROPOSED WITHIN THE HARLEY HAND SOLAR AND STORAGE PROJECT REINVESTMENT ZONE DESIGNATED BY THE COMMISSIONERS COURT OF NOLAN COUNTY, TEXAS ON JANUARY 22, 2024 LOCATED IN NORTHEASTERN NOLAN COUNTY. A MAP OF THE EXISTENT REINVESTMENT ZONE IS AVAILABLE FOR INSPECTION IN THE OFFICE OF THE COUNTY JUDGE.
- C. THE PROPOSED IMPROVEMENTS ARE RELATED TO THE CONSTRUCTION OF SOLAR ENERGY AND STORAGE FACILITY INCLUDING SOLAR PANELS, TRACKING SYSTEMS, BATTERY ENERGY STORAGE SYSTEMS (AS SUCH TERM IS USED IN COMMON LANGUAGE), INVERTERS, TRANSFORMERS, FOUNDATIONS, CONTAINERS, CABLING, COLLECTION LINES, COLLECTION STATIONS, TRANSMISSION LINES, SUBSTATIONS, INTERCONNECTION FACILITIES, OPERATION AND MAINTENANCE FACILITIES, AND OTHER INFRASTRUCTURE, MATERIALS, AND EQUIPMENT CUSTOMARY AND NECESSARY FOR THE OPERATION OF A SOLAR POWER ELECTRIC GENERATION AND BATTERY ENERGY STORAGE FACILITY.
- D. THE ESTIMATED COST OF THE IMPROVEMENTS SHALL BE IN EXCESS OF \$300,000,000.00 WITH RESPECT TO THE SOLAR PROJECT AND \$70,000,000.00 WITH RESPECT TO THE STORAGE PROJECT.

Motion was made by Commissioner Mahaffey, seconded by Commissioner Willman to approve amending the Harley Hand Solar and Storage Project Tax Abatement. Vote was taken and members of the court unanimously voted yes.


