

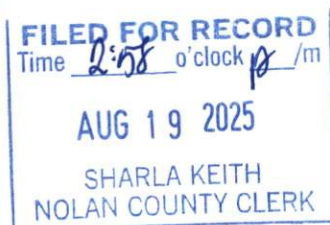

1. PLEDGE ALLEGIANCE TO THE UNITED STATES FLAG

3. APPROVE MINUTES FROM AUGUST 11TH, 2025 MEETING. *(attachment)*

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to approve the minutes from August 11th, 2025 as presented. Vote was taken and members of the court unanimously voted yes. Motion carried.

4. OPEN PUBLIC HEARING ON 2025/026 PROPOSESD BUDGET.

There were no comments or discussions.

5. CLOSE PUBLIC HEARING AND RE-OPEN FOR COMMISSIONERS' COURT BUSINESS.

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to close public hearing and reopen for commissioners' court business. Vote was taken and members of the court unanimously voted yes. Motion carried.

6. CONSIDER APPROVAL TO ADOPT THE 2025/2026 PROPOSED BUDGET AND TAKE RECORD VOTE. *(attachment)*

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to adopt the 2025/2026 Proposed Budget. Record vote was taken, Precinct 1 – Yes, Precinct 2 – Yes, Precinct 3 – Yes, Precinct 4 – Yes, County Judge – Yes. Motion carried.

7. CONSIDER APPROVAL TO ADOPT THE TAX RATE FOR 2025/2026 AND TAKE RECORD VOTE.

Motion was made by Commissioner Willman, seconded by Commissioner White to adopt the No-New-Revenue Tax Rate of 0.4000417 (0.3290923 for General Fund, 0.0709494 for Farm to Market) for 2025/2026. Record vote was taken, Precinct 1 – Yes, Precinct 2 – Yes, Precinct 3 – Yes, Precinct 4 – Yes, County Judge – Yes. Motion carried.

8. RECEIVE AND ACKNOWLEDGE THE 2025/2026 BUDGET FOR NOLAN COUNTY AUDITOR AND DISTRICT COURT REPORTER FROM DISTRICT JUDGE GLEN HARRISON. (attachment)

Motion was made by Commissioner White, seconded by Commissioner Willman to receive and acknowledge the 2025/2026 budget for the County Auditor and District Court Reporter. Vote was taken. Commissioners Willman, White, and Ortega voted yes, Commissioner Mahaffey voted no. Motion carried.

9. CONSIDER APPROVAL OF SHERIFF AND CONSTABLE CIVIL FEE SCHEDULE. (attachment)

Motion was made by Commissioner Mahaffey, seconded by Commissioner Willman to approve the Sheriff and Constable Fees for Fiscal Year 2025/2026. Vote was taken and members of the court unanimously voted yes. Motion carried.

10. CONSIDER APPROVAL OF SECURETECH COURTHOUSE SECURITY SYSTEMS. (attachment)

Motion was made by Commissioner White, seconded by Commissioner Willman to approve SecureTech Courthouse Security Systems, paid out of Courthouse Security. Vote was taken and members of the court unanimously voted yes. Motion carried.

11. CONSIDER APPROVAL OF AN IN-KIND MATCH WITH THE CITY OF ROSCOE.

Motion was made by Commissioner Willman, seconded by Commissioner White to approve the in-kind match with the city of Roscoe. Vote was taken and members of the court unanimously voted yes. Motion carried.

12. OPEN AND RECEIVE BIDS FOR DUMP TRUCK, HAUL TRUCK AND HAUL TRAILER. (attachment)

Motion was made by Commissioner White, seconded by Commissioner Mahaffey to receive the bids from Interstate Trailers, Inc., Roberts Truck Center, Bruckner's, and MHC Texas Kenworth Co, LLC. Vote was taken and members of the court unanimously voted yes. Motion carried.

13. CONSIDER APPROVAL TO AWARD BIDS FOR DUMP TRUCK, HAUL TRUCK, AND HAUL TRAILER.

Motion was made by Commissioner White, seconded by Commissioner Mahaffey to award the bids for Dump Truck to Roberts Truck Center (2025 International), Haul Truck to MHC Texas Kenworth Co, LLC (2026 T880), and Haul Trailer to Interstate Trailers, Inc. (Interstate Model 40TDL). Vote was taken and members of the court unanimously voted yes. Motion carried.

14. RECEIVE REPORTS FROM DEPARTMENT HEADS. (attachments)

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to receive reports from the Texas Wildlife Services Program, the County Auditor Fund Balance Report, and the Nolan County Treasurer Financial Report and Minutes. Vote was taken and members of the court unanimously voted yes. Motion carried.

15. PAY CLAIMS, LINE-ITEM TRANSFERS, AND BUDGET AMENDMENTS AS REQUESTED BY THE COUNTY AUDITOR. (attachment)

Motion was made by Commissioner Mahaffey, seconded by Commissioner Willman to pay bills totaling \$319,143.27. Vote was taken and members of the court unanimously voted yes. Motion carried.

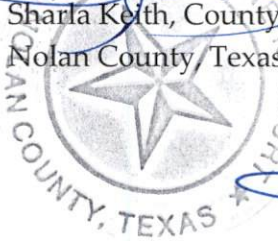

16. ADJOURN.
