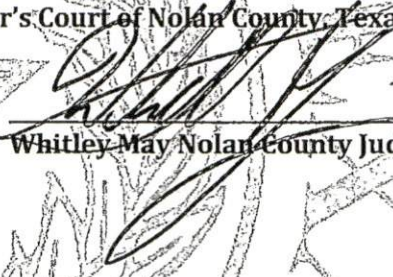

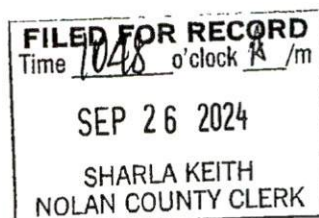
1. Consider approval of 2025 renewal rates for the County Choice Silver program.
